The Phila. Office has completed the installation of a "CAT" in a 1962 Chevrolet Impala bearing New Jersey license GGT 198, which is used exclusively by ANGELO BRUNO of Phila. This car is registered to BRUNO's close associate CHARLES I. COSTELLO, 12468 N. Bayshore Drive, Keystone Point, Miami, Fla., and 714 Puritan St., Laurence Township, New Jersey.

Reception from the "CAT" is usually heard within a four to six city block range; however, on 11/30/62 reception was possible within fourteen city blocks. The "CAT" can be heard on Channel 2, 167.475 MC.

Since offices receiving this airtel, in addition to Quantico, operate on Channel 2 and BRUNO has frequently travelled to Buffalo, N.Y., Trenton, N. J., and Miami, Fla., offices operating on this Channel are being alerted should they experience any traffic in the near future.
