These sources state that so far as they know ROSELLI does not currently have a girl friend living with him at the apartment.

CSLA 4476-C has advised that he is currently going with VICTORIA LOCKWOOD, former girl friend of ROSELLI. She currently resides at 882 North Doheny Drive and has mentioned ROSELLI to source on several occasions. Source has been alerted to endeavor to obtain information concerning ROSELLI's activities from LOCKWOOD.
