RE Bureau airtel dated 7/14/60 and New York letter dated 7/14/60.

SU 446-C advised on 7/18 and 8/5/60 that he knows subject by sight but has not observed him in or around Las Vegas, Nevada, for several months.

BOYD ASHCRAFT, Ashcraft Realty Company, Las Vegas, Nevada, advised SA M. B. PARKER on 8/3/60 that his firm very seldom handles any rental property. He stated that during past four months, so far as he knew, the firm had only handled three rentals, and that two of them were to local people whom he had known for quite some time.

ASHCRAFT advised that his nephew, MARSHAL ASHCRAFT, had handled rental of the MARGO HINES Estate, located in Paradise Valley immediately adjacent to Las Vegas. ASHCRAFT stated that he knew very little of the details, in fact did not even know name of person who had rented the ranch.

MARSHAL ASHCRAFT, Ashcraft Realty Company, advised on 8/4/60 that MARGO HINES had listed her ranch, which is comprised of residence, guest house, swimming pool, stables, etc., covering about 23 acres of land, located at corner of Pecos Road and Sunset Drive in Paradise Valley, near Las Vegas, about five miles from "The Strip", where all major resort hotels are located.
