THE FOLLOWING INFORMATION RECEIVED JANUARY 17 INSTANT FROM POLICE OF PUERTO RICO WHO RECEIVED INFO FROM INFORMANT USING CODE NAME "ACE", WHICH WAS FURNISHED TO SAN JUAN OFFICE IN FORM OF WRITTEN REPORT:

HOFFA TELEPHONICALLY CONTACTED FRANK CHAVEZ THURSDAY PAST AND TOLD CHAVEZ THAT DEPARTMENT ATTORNEY KENNELLY IS IN WASHINGTON, D. C. PREPARING EVIDENCE TO SUBMIT TO FGJ TO INDICT CHAVEZ AND LOCAL 901 ACCOUNTANT LUIS PAGAN FOR MISUSE OF FUNDS AND LOSS OF UNION RECORDS.

ANTHONY PROVENZANO, INTERNATIONAL VICE-PRESIDENT AND PRESIDENT OF A JOINT COUNCIL OF TEAMSTERS, VISITED PUERTO RICO UNDER AN ASSUMED NAME AND STAYED AT THE AMERICANA HOTEL FOR TWO OR THREE DAYS. INFORMANT BELIEVED IT WAS PROVENZANO WHO GAVE CHAVEZ INSTRUCTIONS TO GO TO WASHINGTON TO DIRECT THE AIRLINE DIVISION.
