AT SAN JUAN INTERNATIONAL AIRPORT (SJIA), REVEALED THAT SUBJECT DID NOT IN FACT DEPLANE ANY FLIGHTS ON THE AFTERNOON OF AUGUST 27, 1977. DON ZABALA DEPLANED EARLY IN THE EVENING AT SJIA AND DROVE OFF IN HIS CAR. FURTHER INVESTIGATION BY MIAMI REVEALED THAT SUBJECT FFLEW TO ORLANDO ON EASTERN AIR LINES (EAL), FLIGHT LEAVING 9:15 A.M., AUGUST 28, 1977.
