

It has been previously reported that in January, 1965, STEVE MAGADDINO mentioned that he had "Been in Canada" for 45 years and specifically mentioned Montreal, Quebec, as a location where he had considerable influence.

On April 8, 1968, BU T-16 advised that information was received that on October 17, 1966, GIACOMO LUPPINO, of Hamilton, Ontario, Canada, suspected LCN member, and SANTO SCIBETTA had visited Niagara Falls, New York, where a meeting of about 45 minutes' duration took place between these men and a member of the "Magaddino Family." BU T-16 furnished no further information at this time concerning this meeting.

LCN INTERNAL DISSENSION

On August 25, 1967, BU T-4 advised that leadership in LCN was still vested in STEVE MAGADDINO, with FRED RANDACCIO next in line to assume command of the "Family" contingent upon the outcome of the legal proceedings against him.

On December 26, 1967, BU T-6 in discussing the likely successor to RANDACCIO as Underboss, pointed out that such discussion was pure speculation and that MAGADDINO would not name a successor until all of RANDACCIO's appeals have been exhausted. BU T-6 pointed out that if MAGADDINO should name a successor before RANDACCIO's appeals were decided and RANDACCIO was subsequently released from prison, a power struggle leading to violence would probably evolve between RANDACCIO and whoever was named as his successor.

BU T-6 stated that RANDACCIO is feared by most of his underlings and actually hated by many of them. Many members of the "Magaddino Family" are actually glad that RANDACCIO is now in prison. BU T-6 pointed out that the "Magaddino Family" was then without an "operating head" in Buffalo and, as a result, is in a disorganized state.
