ON NIGHT OF AUGUST TWENTY THREE, ONE NINE SIX EIGHT, NY FOUR THREE THREE SIX - C - TE ACTE ADVISED THAT THE BODY OF CHARLES GAGLIODOTTO, AKA "CHALUTZ", FBI NUMBER FIVE NINE ZERO THREE SIX SIX, PROMINENT MEMBER OF THE GENOVESE "FAMILY" OF LA COSA NOSTRA (LCN), HAD BEEN FOUND IN QUEENS COUNTY, NYC, AND WAS BEING WAKED AT THE FUNERAL HOME OF PASQUALE ALA VECCHIA, TWO SEVEN THREE MOTT STREET, NYC, BEGINNING THE NIGHT OF AUGUST TWENTY THREE, ONE NINE SIX EIGHT, WITH BURIAL ON AUGUST TWENTY SIX, ONE NINE SIX EIGHT.

INFORMANT STATED THAT A MEDICAL EXAMINER FOR QUEENS COUNTY HAD CERTIFIED THAT GAGLIODOTTO HAD DIED OF "A HEART ATTACK".

AS NOTED IN REFERENCED TELETYPE OF AUGUST TWENTY THREE, ONE NINE SIX EIGHT, NY FOUR THREE THREE SIX - C - TE HAD ADVISED "CHALUTZ", WHO HAD PERSONALLY SLAIN FRANK TUMINARO, FBI NUMBER TWO FOUR THREE SIX FIVE EIGHT C, AND FRANK JOSEPH GANGI, FBI NUMBER SEVEN ONE SEVEN EIGHT TWO SIX A, ON THE NIGHT OF AUGUST NINE, ONE NINE SIX EIGHT, IN NYC, WAS HIMSELF MURDERED ON PRINCE STREET, NYC, ON THE NIGHT OF AUGUST TWENTY ONE, ONE NINE SIX EIGHT, IN RETALIATION.

INFORMANT ADVISED ON AUGUST TWENTY THREE, ONE NINE SIX EIGHT, THAT "CHALUTZ" HAD BEEN CHOKED OR SUFFOCATED BY USE OF A PLASTIC BAG PLACED OVER HIS HEAD TO MAKE HIS DEATH APPEAR "NATURAL". THIS INFORMATION WAS PERSONALLY FURNISHED BY SAC RICHARD J. BAKER ON A CONFIDENTIAL BASIS TO ACTING CHIEF OF DETECTIVES CHARLES MC LOUGHLIN, NEW YORK CITY POLICE DEPARTMENT (NYCPD), AND INSPECTOR ROBERT MC GOWAN, COMMANDING OFFICER OF THE CENTRAL INVESTIGATIONS BUREAU, NYCPD, ON AUGUST TWENTY THREE, ONE NINE SIX EIGHT. THIS INFORMATION WAS ALSO FURNISHED ON
