On 9-24-68 Dr. BORIS GIULIANO, Flying Squad, Police Headquarters, Palermo, Sicily, advised that the report of denouncement charging 90 persons with aggravated criminal conspiracy to import and export narcotics to and from Italy is being studied by Investigating Magistrate ALDO VIGNERI of Palermo. According to GIULIANO, VIGNERI may not announce his findings for several months.

With regard to the acquittal in June, 1968, of the 17 defendants charged with aggravated criminal conspiracy, GIULIANO advised the appeal is still pending before the Palermo Court of Appeals and at this time there is no indication when the court will render a decision.

Any information of pertinence developed in this matter will be forwarded to the Bureau promptly.
