AS A RESULT OF CLOSE COORDINATION BY FBI AND ^{NEW YORK STATE POLICE} NYSP DE CICCIO AND CARMEN C. BONANNO ^{also known as} AKA BANANNAS CLOSE ASSOCIATE OF FRANK VALENTI WERE ARRESTED BY ^{NEW YORK STATE POLICE} NYSP AT APPROXIMATELY EIGHT FIFTY FIVE PM TONIGHT.
