OLEAN, NY PD RAIDED ROOM AT CENTRAL HOTEL, OLEAN, NY, NOV. TWENTYEIGHT, LAST, WHERE TWENTYTWO PERSONS ENGAGED IN GAMBLING ACTIVITIES.

JOSEPH PEZZMENTI, BORN SEPT. EIGHTEEN, NINETEEN EIGHTEEN AND ALEXANDER SIMON, BORN NOV. FOUR, NINETEEN EIGHTEEN, ARRESTED AND CHARGED WITH PROMOTING GAMBLING AND POSSESSION OF GAMBLING DEVICES.

OTHER TWENTY PARTICIPANTS NOT CHARGED. PEZZMENTI AND SIMON RELEASED ON TWO HUNDRED FIFTY DOLLARS BAIL EACH; ARRAIGNMENT POSTPONED TO DEC. SIX, NEXT.

ONE HUNDRED DOLLARS IN GAMBLING DEVICES SEIZED. FORTY DOLLARS SEIZED FROM DICE TABLE.

BU FOUR ONE ONE DASH C FURNISHED INFO RE ABOVE GAMBLING ACTIVITY AND THISS INFO AIDED INVESTIGATION BY OLEAN PD.

LT. ARTHUR FILJONES, OLEAN, NY PD, ADVISED THAT AFTER CURSORY EXAMINATION OF RECORDS, HE WOULD ESTIMATE THE WEEKLY ACTION AMOUNTED TO APPROXIMATELY ONE THOUSAND DOLLARS.
