Re Rome cables to the Bureau March 15 and 19, 1968; Bureau airtel to Rome and New York 4-1-68 captioned VICENZO MARTINEZ; AR.

Dr. BORIS GIULIANO, Flying Squad, Police Head-quarters, Palermo, Sicily, advised on 4-10-68 that the trial in Palermo was adjourned on 3-16-68 to 4-26-68. According to Dr. GIULIANO, the answers to the interrogatories executed by GERALD SHUR, Organized Crime and Racketeering Section, had not yet been introduced at the trial. Dr. GIULIANO said he will keep Legat informed of any significant developments concerning the trial and particularly the manner in which the answers to the interrogatories are used.

Dr. GIULIANO will also furnish pertinent newspaper publicity which appears in Italian newspapers, and Legat will submit to the Bureau all pertinent information developed in a form suitable for dissemination.
