On 5/7/68, NK 2342-C-TE advised that JOSEPH ZICARELLI, New Jersey top hoodlum, stated the "feud" between the people in New York has been settled. ZICARELLI did not further elaborate; however, informant stated evidentially the bid for power between the DE GREGORIO-BONANNO "families" has been settled. Informant stated that should further information develop concerning the above he would immediately advise CONTACTING AGENT.

Informant said ZICARELLI has been around town smiling and stating that if they were going to "hit" me they would have "hit" me by this time.

Informant said ZICARELLI had PETE POLICASTRO, private detective and electronics expert, ~~to~~ check out the phones and the law offices of Dembe and Representative CORNELIUS GALLAGHER in Bayonne and the offices of ED and HARVEY DEMBE in the Bayonne National Bank. According to informant, POLICASTRO did not uncover any electronic devices at these locations.
