indication that any ramifications would result or that there was any danger to the life of LA 4448-C-TE, but, according to informant, merely made this known to him as a precaution so that he would not have confidential conversations.

The exact detailed significance of the above information is not known to the Los Angeles Division at this time and, based on the above information, contacts with logical informants are being observed closely in an effort to pick up any information which would bring forth the significance of the above conversation.

It is noted that the Agent having contact with LA 4711-C-TE in no way gave any indication when this information was learned that LA 4448-C-TE was a source of the Bureau and in order to protect the identity of this informant, no detailed specific questions were asked. However, the informant volunteered that this was the extent of the information furnished to him and stated that he had no additional information in this regard.

The Bureau will be kept closely advised of any information learned in this regard.
