The money order was sent by one JERRY CLARK, Warwick Hotel, at 7:05 PM, September 26, 1961, was in the amount of \$50.00 and was sent from the National Telegraph Office at Front and University Streets in Toronto.

BATTERSBY and ROSS advised two airline tickets were purchased at the Trans Canada Airline Office in the Royal York Hotel on September 25, 1961, for travel by MARY and JANE O'BRIEN from Cleveland, Ohio, to Toronto, Ontario, Canada. The tickets were purchased by Mrs. SIMONE JOHNSON, 550 Spadina Avenue, Toronto, telephone number WA 5-4008

BATTERSBY and ROSS stated investigation at 550 Spadina Avenue, disclosed that no one by the name of SIMONE JOHNSON, LARRY PARKS or JERRY CLARK resided at this address and further that telephone number WA 5-4008 is listed to Apartment 504, 710 Spadina Avenue, Toronto.

BATTERSBY and ROSS stated investigation at 710 Spadina disclosed one P. KIRBY resides in Apartment 504 with a woman who answers the description of SIMONE JOHNSON. They stated repeated efforts to locate KIRBY and/or JOHNSON for interview have met with negative results.

BATTERSBY and ROSS stated they have been unable to locate LARRY PARKS or a JERRY CLARK for interview.
