ATTORNEY DAVID WALTERS, 100 BISCAYNE BOULEVARD, MIAMI, FLORIDA, SUBJECT'S LAWYER, ADVISED ON AUGUST 3, 1976, THAT HE WOULD ADVISE SUBJECT'S SISTER, EDITH DAIGLE, TO FILE A MISSING PERSONS REPORT WITH LOCAL AUTHORITIES AT BROWARD COUNTY, FLORIDA. HE SAID HE ALSO WOULD NOTIFY THE CHIEF CONSUL, SENATE SELECT COMMITTEE ON INTELLIGENCE, CHAIRED BY SEN. FRANK CHURCH, THAT THE SUBJECT HAS BEEN MISSING FROM SISTER'S RESIDENCE, PLANTATION, FLORIDA, SINCE JULY 28, 1976, AND PROBABLY HAS MET WITH FOUL PLAY.

MRS. DAIGLE, 5220 S. W. 10TH COURT, PLANTATION, FLORIDA, STATED ON AUGUST 3, 1976, THAT HER BROTHER, JOHN ROSELLI, LEFT HER RESIDENCE AT APPROXIMATELY 1:00 P.M., JULY 28, 1976. HE GAVE NO INDICATION OF KEEPING AN APPOINTMENT, BUT SAID, "I WILL SEE YOU LATER" AND LEFT IN MRS. DAIGLE'S 1975 CHEVROLET IMPALA,
