[redacted] (PH 525-C) was recontacted pursuant to relets 9/4/59 by SA FREDERICK T. HOULIHAN. [redacted] said he would agree to allow the information which he furnished to SA GEORGE R. JOHNSON regarding MEDICO and BUFALINO to be given to the Department for review. He said he would not agree to furnish the Department with other information which he has furnished to the FBI.

He said he has already been served with a subpoena by Agents of the U. S. Treasury Department to appear as a witness 10/26/59 in New York City. He said his employer, LOUIS PAGNOTTI, had also been served with a subpoena to appear the same date. He said in view of this he was willing to testify to the information regarding MEDICO and BUFALINO which he furnished to SA JOHNSON.
