Re New York airtel, 10/12/67.

MM 676-C advised on 10/31/67 that JIMMY PALACINA, a shylock, advised that PALACINA has a nephew in New York who is a lieutenant of JOE BONNANOS and that this nephew had control of BONNANOS' organization during the period that BONNANOS was in hiding. Informant stated that PALACINA refers to this nephew as "SMITHY" and the informant has no further identifying data other than the fact that "SMITHY" is preparing for a large wedding for his daughter to take place in New York in a couple of weeks.

Informant advised that PALACINA told him that when BONNANOS returned to New York, there was a split in the BONNANOS "family" and that the group that was in power during BONNANOS' absence, which group included "SMITHY", was not going to allow BONNANOS to regain his former power. PALACINA advised informant that a gang war was expected because of this fight for power and that PALACINA was endeavoring to obtain weapons for "SMITHY" in this regard.
