On October 30, 1967, MI 623-G-TE was contacted by SAs JOHN W. ROBERTS, JR., and BRADNER C. RIGGS of the Chicago Division and SAs CARLYLE N. REED and DANIEL BRANDT of the Milwaukee Division. The purpose of this contact was for an in depth discussion with the informant relative to the Rockford LCN family. Informant pointed out that GEORGE SALADINO, deceased LCN member, had a large well organized gang operating in Rockford, Illinois. TONY MUSSO, deceased, was the boss of the Rockford LCN family at that time. PHIL PRIOLA and PHIL CANNELLA, who are currently Rockford LCN members, were members of SALADINO's gang. He said that JOE ZITO even at this early period was very wealthy as a result of successful bootlegging operations and had nothing to do with this group except to loan SALADINO money from time to time to finance his operation. He said that PHIL PRIOLA was sought by Federal authorities under the name of PHIL VALLINO for a kidnaping which he was involved of one FRED DE PHILLIPI of Spring Valley, California. He said prosecution against PRIOLA was dropped when DE PHILLIPI was killed in an automobile accident.
