LA FOUR FOUR FOUR EIGHT C-TE PREVIOUSLY ADVISED THAT LA LCN "CAPO" ANGELO POLIZZI HAD RECENTLY BEEN HOSPITALIZED AS A RESULT OF A CARDIAC CONDITION. ON NIGHT OF NOVEMBER FIFTEEN LAST, INFORMANT IN TELEPHONIC CONTACT WITH POLIZZI. POLIZZI AT THIS TIME TOLD INFORMANT THAT HE HAD SUFFERED A STROKE WITHIN PAST TEN DAYS AND WAS PRESENTLY CONFINED TO HIS HOME UNDER HIS PHYSICIAN'S CARE.

ON NIGHT OF NOVEMBER SIXTEEN LAST, LA FOUR FOUR FOUR EIGHT C-TE TELEPHONICALLY ADVISED THAT HE WAS PRESENTLY IN SAN DIEGO, CALIFORNIA AND IN PERSONAL CONTACT ON THAT DATE WITH LCN "MEMBER" FRANK BOMPENSIERO.

BOMPENSIERO TOLD INFORMANT THAT HE HAD RETURNED FROM A TEN DAY TRIP TO CLEVELAND, OHIO, ON THAT NIGHT OF NOVEMBER THIRTEEN LAST. WHILE IN CLEVELAND, BOMPENSIERO HAD BEEN IN CONTACT WITH LCN "MEMBER" LEO MOCERI. MOCERI INDICATED THAT HE MAY VISIT CALIFORNIA IN THE NEAR FUTURE AND IN SUCH EVENT HE WOULD BE IN CONTACT WITH INFORMANT.

BOMPENSIERO ALSO TOLD INFORMANT THAT HE HAD BEEN IN CONTACT WITH SAN DIEGO LCN "CAPO" JOSEPH ADAMO SINCE HIS RETURN TO SAN DIEGO AND THAT ADAMO TOLD HIM THAT "CAPO" JOSEPH DIPPOLITO HAD BEEN APPOINTED LOS ANGELES LCN "UNDERBOSS". BOMPENSIERO TOLD INFORMANT HE DID NOT PRESENTLY KNOW WHO HAD BEEN APPOINTED "CAPO" TO REPLACE DIPPOLITO.

LA FOUR FOUR FOUR EIGHT C-TE PLANS TO RETURN TO LA ON NOVEMBER SEVENTEEN INSTANT OR EIGHTEEN NEXT. HE WILL ATTEMPT TO CONTACT LCN "BOSS" NICK LICATA OR "CAPO" ANGELO POLIZZI IN AN ATTEMPT TO VERIFY ABOVE APPOINTMENT OF JOSEPH DIPPOLITO AS LA LCN "UNDERBOSS."
