He stated that HALPERIN's and BRUNO's plans are to get 10 men to put up \$50,000 each and purchase the Bonanza outright with an arrangement being made to have the mortgage payments deferred for seven to ten year Informant advised that the Bonanza is a multimillion dollar enterprise, however, reportedly has been losing money. Informant further advised that the major obstacle to this operation taking effect now is presented by JOSEPH COLOMBO, "boss" of the COLOMBO "family". Informant stated that COLOMBO has stated that he does not care who comes up with the money and has no objection to the operation described above; however, stated that regardless of who was involved he would retain a piece of the Bonanza.
