MM 676-C advised that "Smitty" broke with the Bonnano Family during the period of JOE BONNANO's absence and that his partner, JOHNNY, remained with the Bonnano Family. "Smitty" had been warned about the individual who shot him.

PALACINO related to MM 676-C that nine individuals including JOE BONNANO, were scheduled for hits over this situation and that one of them had already been killed in New Brunswick, New Jersey.

PALACINO advised MM 676-C that he anticipated extensive gangland warfare between the two factions.

PALACINO also related that he had been interviewed while in New York by authorities concerning the D'ANGELO murder but did not state the identity of these authorities.

Miami is considering the interview of PALACINO and if he has been interviewed by New York if is requested that the Miami Office be advised.
