SD 1064-C-TE was re-contacted 11/16/67 and furnished the following information on the LCN:

I. SAN DIEGO DIVISION

For the information of New York, JIMMY "THE WEASEL" FRATIANNO (true name ALADENA T. FRATIANNO), a close friend of the informant who was formerly an LCN member in the Los Angeles Family and who is presently an LCN member of the Chicago Family, was indicted by the Federal Grand Jury at San Diego on 11/9/67 (San Diego case 92-504). The Federal Grand Jury at San Diego returned a 28 count indictment against FRATIANNO, his wife JEWEL FRATIANNO (President of the Fratianno Trucking Corporation) and the Fratianno Trucking Company of Sacramento, California.
