MM 1231-C-TE advised 12/1/67 that he had been in contact briefly with TONY "DUCKS" (CORALLO) while the latter had been stopping at the Diplomat Hotel, Hollywood, Florida, and was told that JOE PALAZZI (phonetic) is definitely the new head of the LUCHESE Family, LCN, and CORALLO is number two man. TRAMUNTI has been shifted back to his former position.
