This is being pointed out for the information of the Bureau, Kansas City, and auxiliary offices as an indication of the degree of reliability of KC 586-C-TE.

At the next opportune time when contacting KC 586-C-TE, obtain as much information as possible concerning the following:

The reasons for and persons involved in the slaying of ANTHONY BIERNAT, Kenosha, Wisconsin, in January, 1963. BIERNAT's body was found in an abandoned basement on the abandoned site of the Bong Air Force Base, Kenosha County, Wisconsin. Indications are that BIERNAT, an independent jukebox operator, would not accept to demands of the outfit in connection with his business. Persons whom Milwaukee considers knowledgeable about BIERNAT's murder or may have been actual participants in this slaying are: STEVE DE SALVO; FRANK STELLOH (a strong arm man and ex-con, who now works for FRANK BALISTRIERI, the Milwaukee boss); WILLIAM "WEASER" COVELLI, who is a Kenosha jukebox operator; DOMINIC "POPS" PRINCIPE of Kenosha, Wisconsin, and Zurich, Illinois; "BUSTER" BALESTRERE; and JOE GURERA, both of Kansas City, who were working for FRANK BALISTRIERI in Milwaukee in January, 1963. In the event discussion of this matter with informant might alienate him or otherwise cause undue concern when considered in relation to his overall value as a TE, it is being left to the discretion of Kansas City as to the propriety of questioning the informant along these lines.

Is informant aware of any division of organized gambling in Kenosha, Wisconsin? It is reported that in this split at Kenosha, one group, including "WEASER" COVELLI and JOHN RIZZO, is under the control of FRANK BALISTRIERI at Milwaukee, and the other group is controlled by the Chicago organization.
