He recalled another LCN Member as SCOTTY who was a gambler living in Pueblo and who might have moved to Denver, Colorado.

For the information of Denver, the informant has also identified ARTHUR DI MARIA of Las Vegas and a JULIE (possibly JULIAN ANTISTA) as two LCN Members of the Los Angeles family who originally came out of the Denver area.

For the information of the Los Angeles Division, the informant confirmed appointment of Capo JOE DIPPOLITO as the new under boss to NICK LI CATA. The informant advised that he learned from his Capo JOE ADAMO that JAMES PHILIP REGACE has recently been appointed by boss NICK LI CATA to the position of Capo taking DIPPOLITO's place. He identified REGACE as a used car lot operator in East Los Angeles who was made an LCN member in Los Angeles in about 1948 or 1949. REGACE was sponsored by JIMMY FRATIANNO. Informant belicved REGACE came from Cleveland originally and was brought to Los Angeles by MICKY COHEN. At one time he was a collector for COHEN.

Denver is requested to furnish photographs and background information on any suspected LCN Members which could be used to further question the informant for backgound and identification purposes.
