On 7/31/67, DE 1110-C advised that SILVIO PERRETTA was returning to Italy where he intended to stay permanently.

On 8/25/67, the same source advised that SILVIO PERRETTA had received a very severe physical beating from the Detroit mafia boys prior to his leaving Detroit for Italy.

During interview with PERRETTA 6/15/67, he advised SA PAUL EDWARD EIDEN he was no longer connected with TONY ZERILLI in the restaurant business and that he was planning to return to Italy because of poor health.

It is requested that the enclosed LHM be furnished the Legat in Rome with the request that appropriate inquiries be made to establish that SILVIO PERRETTA is, in fact, in Italy and further, to make any appropriate inquiries in an effort to substantiate information furnished in LHM.
