MARCO LI MANDRI is old and reported by informants to be in poor health at this time. As of 1/15/68, he was residing at his home, 4879 Austin Drive, San Diego. He resides there alone since the death of his wife last August.

At the last meeting with SD 1064-C-TE on 1/3/68, he advised MARCO LI MANDRI's son, LCN member JOSEPH JOHN LI MANDRI of San Diego (SD 92-77), will be going to Miami in the near future. For the information of Miami, JOE LI MANDRI is business agent for Local 402, Culinary Alliance and Hotel Service Employees Union. He will be attending the convention in Miami Beach with the president of Local 402, Mr. DUDLEY WRIGHT of San Diego.
