MEETING TO BE HELD AT LONG ISLAND RESIDENCE OF PAUL VARIO, LUCHESE FAMILY. ALL ATTENDEES WILL ARRIVE BY BOAT, NOTED VARIO MAINTAINS RESIDENCE ON SHORE.
