SD 1064-C-TE was recontacted 1/18/68 and furnished the following information on the Cosa Nostra.

SACRAMENTO AND SAN FRANCISCO DIVISIONS

On 1/14/68, informant flew from San Diego to San Francisco where he joined BOB TEGAY and GAIL FARRUP who operate 7-11 Tours, a travel agency located on Mission Street, in San Francisco. Together they flew via United Air Lines to Honolulu. Informant, TEGAY and FARRUP had reservations at Waikiki Inn but upon arrival changed plans and stayed on 25th floor of hotel next to Waikiki Inn. Informant used alias FRANK GAVIN, TEGAY used alias ROBERT HILL and FARRUP used his own name.

Purpose of trip was attempt to form combine of individuals sending gambling junkets to Nevada. They met with following persons in Honolulu:
