

Miami Beach, Florida.

PCI WILLIAM H. DICKSON advised SA ROBERT F. FETZNER on June 4, 1959, that the Biltmore Terrace had been sold, and the new owners have incorporated, on April 24, 1959, under the name Alcama, Inc. The officers are CAPPY MILES ROTHMAN, age 21, student at the University of Miami, as secretary; ALBERTO ARDURA MOYA is listed as president; and CEASAR ALONZO is listed as vice president.
