From information furnished by EDWARD HART,
it appears that the person referred to by him as ALBERTO
MAYO is probably identical with ALBERTO ARDURA MOYA. Accord-
ing to files of the Miami Office, ARDURA, former treasurer of
the Tropicana Night Club in Havana, Cuba, and NORMAN ROTHMAN,
are two of the new owners of the Biltmore Terrace Hotel,
Miami Beach, Florida.

PCI WILLIAM H. DICKSON advised SA ROBERT F. FETZNER
on June 4, 1959, that the Biltmore Terrace had been sold, and
the new owners have incorporated, on April 24, 1959, under
the name Alcama, Inc. The officers are CAPPY MILES ROTHMAN,
age 21, student at the University of Miami, as secretary;
ALBERTO ARDURA MOYA is listed as president; and CEASAR
ALONZO is listed as vice president.

The Bureau is requested to furnish any information in
Bureau files which is not in possession of Miami concerning
ALBERTO ARDURA MOYA.
