NORMAN ROTHMAN, RA - CUBA. ROTHMAN POSSESSES OPEN RETURN TICKET AND RESERVATION, GUEST AIRWAYS, DEPARTING MIAMI FLIGHT ONE ZERO ONE, FIVE PM, EST., DEC. TEN NEXT, ARRIVE MEXICO CITY NINE TEN PM., DEC. TEN NEXT, MEXICO TIME, BELIEVED TRAVELLING ALONE. ON THIS DATE, JAMES P. DOWRICK, JR. CONFIDENTIALLY ADVISED SUBJECT PERSONALLY INFORMED HIM HE WAS GOING TO YUCATAN, MEXICO SEEKING SITE FOR BASE OF OPERATIONS AGAINST CASTRO GOVERNMENT BECAUSE AREAS IN U.S. TOO CLOSELY GUARDED. DOWRICK STATED ONE BARNEY BARNETT, BROTHER OF OWNER, QUOTE EL PATIO END QUOTE RESTAURANT, MIAMI BEACH, IS ASSOCIATE OF ROTHMAN AND SAID ROTHMAN IN CONTACT WITH ALBERTO VARDURA MAYA AND ROBERTO FERNANDEZ MIRANDA OF BILTMORE TERRACE HOTEL, MIAMI BEACH, WHO REPRESENT BATISTA. FURTHER, ROTHMAN DESIROUS OBTAINING CONTACT TO PERFORM QUOTE SERVICES END QUOTE FOR BATISTA GROUP, PERTAINING TO ACTIVITIES AGAINST CASTRO GOVERNMENT. ROTHMAN HAS BEEN INDICTED AND CURRENTLY ON BOND ON TWO FEDERAL CASES.
