NORMAN ROTHMAN, REGISTRATION ACT - CUBA. ROTHMAN POSSESSES OPEN RETURN TICKET AND RESERVATION, GUEST AIRWAYS, DEPARTING MIAMI FLIGHT ONE ZERO ONE, FIVE PM, DECEMBER TEN, INSTANT, SCHEDULED TO ARRIVE MEXICO CITY NINE TEN PM, MEXICO TIME, DECEMBER TEN, INSTANT. BELIEVED TRAVELING ALONE. JAMES P. DOWRICK, JR. ON DECEMBER NINE, LAST, CONFIDENTIALLY ADVISED MIAMI SUBJECT PERSONALLY INFORMED HIM HE WAS GOING TO YUCATAN, MEXICO, TO SEEK SITE FOR BASE OF OPERATIONS AGAINST CASTRO GOVERNMENT BECAUSE AREAS IN U.S. TOO CLOSELY GUARDED. ROTHMAN REPORTED DESIROUS OF OBTAINING CONTRACT TO PERFORM SERVICES AGAINST CASTRO GOVERNMENT FOR BATISTA GROUP. HE HAS BEEN IN CONTACT WITH ALBERTO ARDURA MAYO AND ROBERTO FERNANDEZ MIRANDA OF MIAMI BEACH, FLORIDA, WHO REPRESENT BATISTA. DURING BATISTA REGIME, ROTHMAN REPORTEDLY OPERATED GAMBLING CONCESSIONS IN CUBA. HE HAS BEEN INDICTED AND IS CURRENTLY ON BOND IN TWO
