EVELYN WRIGHT previously mentioned in this report has not been known to frequent the Richmond area since arrested by the Richmond Police Department in February, 1954.

Criminal Informant RH 51-6-C advised that a group of free lance prostitutes continue to frequent the White Tower Restaurant, Third and Grace Streets, Richmond, Virginia, and he has recently noticed that many of them appear to be using narcotics.

LOUIS BRAUTIGAN or BRATTINGEN was previously reported to have in his possession a considerable amount of obscene goods at 2222 West Grace Street. An examination of some of these goods has determined that some of the obscene photographs are of JUANITA DALE PHILLIPS who is identical to an individual appearing in photographs submitted by the Dallas Office. Further information on at least one other photograph of obscene nature indicated that perhaps they were produced at Fort Bragg, North Carolina.

RUTH MONA THOMPSON, a PCI of the Richmond Office; continues to operate as a prostitute at 645A West Broad Street, Richmond, Virginia.

MARTHA THOMAS, new COYLE, a known madam of the Richmond area for a long time, was previously reported to have been working behind the steamcounter of the Hot Shoppe Cafeteria, Richmond, Virginia.

Recent checks have noted that THOMAS, nee COYLE, has not been observed working at the Hot Shoppe Cafeteria for sometime. Present whereabouts or activities have not been determined.

Captain DAN DULING, Vice Squad, Richmond Police Department advised there has been no material change in the condition and status of the numerous Negro Clubs operating on Second Street in the vicinity of Marshall and Clay Streets.
