On 5/19/67, NO 1457-C-TE advised that Attorney MICHAEL MAROUN telephonically contacted JACKIE MARCELLO, CARLOS MARCELLO's wife, from New York City and advised her that CARLOS and JOSEPH MARCELLO had won their case with the Queens County, New York, Grand Jury. Approximately half an hour later CARLOS MARCELLO called JACKIE MARCELLO and CARLOS and JOSEPH MARCELLO spoke with JACKIE and ANASTASIA MARCELLO. This call emanated from a pay telephone booth in New York City. CARLOS and JOSEPH MARCELLO were jubilant over being discharged by the Queens County Grand Jury.

CARLOS MARCELLO stated that he wished to throw a large victory celebration during the night of 5/19/67.

On 5/19/67, NO 1457-C-TE advised that a victory celebration would be held night of 5/19/67 at Elmwood Plantation. Elmwood Plantation is owned by JOSEPH MARCELLO. Informant stated that several of the dining rooms would be closed to the public and that CARLOS MARCELLO was paying all expenses for the evening. Informant stated about 150 people are expected at this celebration. Informant will attend this celebration.
