Dr. ARISTIDE MANOPULO, Central Bureau, Criminal Division, Italian National Police (INP), Rome, Italy, advised on 5-24-67 that the date of the trial of the 17 persons charged with aggravated criminal conspiracy has not been set. He expressed the opinion that the trial will not be held until the Fall of 1967. ~~(u)~~

According to Dr. MANOPULO, FRANK GAROFALO's appeal to the Public Prosecutor in Palermo for provisional liberty has been denied and he continues to be confined in jail at Palermo, Sicily. ~~(u)~~
