WARRANTS. [REDACTED] HAS PREVIOUSLY ATTENDED GAMBLING AFFAIRS AT THE CLUB. CAPTAIN KENNEDY HAS ADVISED THAT A COMPLAINT BY [REDACTED] COUPLED WITH INFORMATION RECEIVED FROM BUFFALO INFORMANT WILL BE SUFFICIENT TO SUSTAIN SUCCESSFUL COURT ACTION AGAINST PARTICIPANTS AND OVERSEERS OF THIS ILLEGAL GAMBLING OPERATION. IF [REDACTED] IS SUCCESSFUL IN ENTERING THE GAME, THESE WARRANTS WILL BE EXECUTED TODAY BY OFFICERS OF THE BUFFALO PD, GAMBLING SQUAD. CAPTAIN KENNEDY HAS ADVISED THAT HE WILL CHARGE ALL PARTICIPANTS IN THE GAME WITH VIOLATION OF SECTION NINE FOUR THREE OF THE BUFFALO CITY ORDINANCE (ILLEGAL FREQUENTING OF GAMBLING ESTABLISHMENT) AND THE OPERATORS OF THE GAME WITH VIOLATION OF SECTION NINE SEVEN THREE OF THE ^{New York State} ~~NYS~~ PENAL LAW (MAINTAINING PREMISES FOR GAMBLING).

IF THE ABOVE PLANS MATERIALIZE, BUFFALO AGENTS ANTICIPATE DISCREETLY OBSERVING THE EXECUTION OF THESE WARRANTS IN ORDER TO SECURE BUREAU INTEREST.
