OTHER 4 FOREIGN

ORLANDO ~~BOSCH~~ ~~AVILA~~ was taken in custody in Costa Rica in the house of a woman who had rented the house without knowing anything about the subject. (S)

Reportedly, FLORE ROLANDO MENDOZA made the arrangements for this house but security agencies in Costa Rica could find no record to verify his entrance, departure, or presence in Costa Rica. (S)
