On May 4, 1976, SJ T-4 advised that the subject met with other AC members and anti-Castro Cubans at a restaurant and bar named El Caney on Roosevelt Avenue in San Juan, Puerto Rico, and Bar La Laguna, which he believed was in the Condado area of San Juan. Source advised that he had been told that at these meetings those present talked about trying to frighten the pro-Castro Cubans living in Puerto Rico and also talking about pressing Cuban businessmen in Puerto Rico to contribute to groups.

On June 2, 1976, SJ T-2 advised that he observed the subject and Aldo Vera, accompanied by four or five AC followers in Casa Cuba on both May 20 and 21, 1976. The subject mentioned to the source that AC is now in a political stage, but that it would shortly evolve into an action combat stage. Cruz Pino attempted to take over the microphone at the Casa Cuba and give an impromtu political pep talk; however, the President of Casa Cuba stepped forward and stopped Cruz Pino from finishing his speech. According to source, Casa Cuba is a Cuban Social Club and its bylaws forbid the use of club facilities for political reasons. Casa Cuba is located in the Isla Verde section of San Juan, Puerto Rico

In view of the subject's leadership in AC, which carried out terrorist activities directed against Cuban embassies around the world, a full investigation covering subject's involvement is being continued.
