### ALLEGED ATTEMPTED BRIBE OF EDWARD IVAN ARTHUR BRIBERY

Reference is made to a letter dated January 28, 1974, from Henry E. Petersen, Assistant Attorney General, Criminal Division, United States Department of Justice (HEP:HSD:am), to the Director, FBI, captioned "Allegations by Edward Ivan Arthur."

The above letter requested that Arthur be interviewed and results furnished to the Department. Enclosed for the Department are two copies of the interview of Edward Ivan Arthur conducted on February 4, 1974, at Columbus, Ohio.

For the information of the Department of Justice, Edward Ivan Arthur has an extensive police record with the Columbus, Ohio, Police Department under Columbus Police Department number 45036. Arthur has FBI number 722-936 B. A review of Columbus Police Department file number 45036 reflects Arthur was arrested on October 22, 1957, by Columbus Police Department on a charge of attempted blackmail. The charge was filed by John George Warhol, Jr., date of birth September 2, 1933, place of birth Park Ridge, New Jersey. A review of the case reflects Warhol committed acts of sodomy on Arthur and was thereafter blackmailed by Arthur. Comments in the case file reflect Arthur's modus operandi was to "roll" queers or pick up queers and after engaging in sexual act with them would attempt to obtain money by threat of blackmail.
