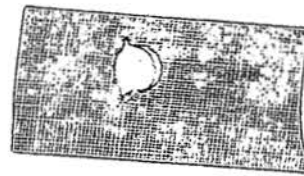
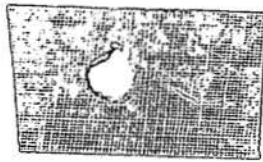

WEEKLY SUMMARY

Re Chicago airtel summary, 1/27/61.

PCI [redacted] advised on 1/30/61, that she observed GIANCANA on 1/29/61, unaccompanied at the Armory Lounge in Forest Park, driving a 1959 Ford Galaxie. The 1961 license number for this automobile is GW 7896.

It is noted that the Miami Office advised by airtel that GIANCANA was as of 1/23/61, back in Miami Beach, Florida at the Fontainebleau Hotel.

Records of the Playboy Club, 116 E. Walton Place, CHICAGO, ILL. were checked on 1/27/61, and it was ascertained that SAM FLOOD has a key to this establishment giving a residence address of 2801 North Sheridan Road, Chicago.

A pretext inquiry was made at 2801 North Sheridan Road, Chicago, which is a multi story luxury type apartment building and it was ascertained that there is no SAM FLOOD listed as a tenant therein. It was noted, however, that DONALD MEDLEVINE, former co-owner of the Chez Paree night club in Chicago, is a tenant in apartment 1520. According to records of the Playboy Club, MEDLEVINE was given as the sponsor for GIANCANA's membership. There was a notation on GIANCANA's card made in large capital letters and heavily underlined to the effect that no correspondence or communications were to be sent to this member and all inquiries should be directed to VIC LOWNES, partner of the Playboy Club.
