to CG T-3. Informant continued that JAMES, for his part in the negotiations, will receive approximately \$1,000 per month from GIANCANA, et al, while JAMES is in the penitentiary. This \$1,000 a month will actually be contributed by JOHN DREW from the latter's interest which is \$6,000 per month. (u)

According to CG T-3, the kingpin in the negotiations in Las Vegas was GIANCANA, ably assisted by ANTHONY ACCARDO and MURRAY HUMPHREYS. (u)

According to the informant, the negotiations are not quite complete at this time. However, for all practical purposes, the contract is sealed and the only part remaining will be the "picking up of loose ends." The informant clarified the latter by stating that it will be necessary now to obtain clearance from the Nevada Gaming Commission and other State of Nevada officials for individuals that GIANCANA, et al, plan to place as official holders of the points which have been obtained. The informant continued that the contribution given by this group amounts to approximately \$36,000 per month. The return on this investment is unknown to the informant. (u)

CG T-3 continued that MURRAY HUMPHREYS, GUS ALEX, and FRANK FERRARO were also included in these negotiations although they did not take an active part in the final stages. (u)

Gambling

Gus' Steak House

CG T-17 advised on December 16, 1960, that Gus' Steak House, which is located on Roosevelt Road and 48th Court, Cicero, Illinois, is a restaurant operated by the "gambling syndicate." The money for this establishment was put up by JOHNNY KRINGLES, brother of GUS KRINGLES. This is the family who are also partners in the funeral parlor at Kringles and Margulos. (u)
