SAMUEL M. GIANCANA, AKA., AR. DAILY SUMMARY. MIAMI ADVISED THAT DUKE STEWART, MANAGER, FONTAINEBLEAU HOTEL, MIAMI BEACH, ADVISED AGENTS ON FEB. FIFTEEN LAST THAT HOTEL POLICY FORBADE MAKING RECORDS OF GUESTS AVAILABLE IN ABSENCE OF SUBPOENA, AND SAID THAT IN FUTURE CONTACTS WOULD NOT CONFIRM OR DENY PRESENCE OF GIANCANA THAT HOTEL. MIAMI ADVISED FLORIDA FELON ACT REQUIRES PERSON CONVICTED OF FELONY IN LAST TEN YEARS TO REGISTER WITH LOCAL AUTHORITIES. GIANCANA DOES NOT FIT THIS CATEGORY. FISUR, ARMORY LOUNGE, MIDNIGHT TO EIGHT A. M. THIS DATE, REVEALS ELDERLY CARETAKER FOR ARMORY RESIDES ONE BLOCK WEST OF ESTABLISHMENT AND WALKS TO WORK. CONTACTED BY ROCCO POTENZO SEVERAL MONTHS AGO AND WAS OFFERED ONE THOUSAND DOLLARS PER MONTH TO KEEP GAMBLING OPERATION GOING AT AIRLINER LOUNGE, ROSEMONT. STEPHENS REFUSED OFFER AND ORDERED OPERATION CLOSED. NOTED THAT POTENZO IS CHIEF LIEUTENANT OF GIANCANA FOR NORTHWEST SUBURBS AND REPUTED OPERATOR OF AIRLINER FOR GIANCANA.
