It is the location of wire service and gambling and the net take at this Lounge averages about \$2,000 a day. The total amount of betting made each day at this place amounts to between \$5,000 and \$7,000. entire operation at the Riviera Lounge is handled by one Jasper Pelicone, muscle man for Potenzo. Hodl also informed that Giancana's northwest side racketeering group meets at the Guys and Dolls Bar every Tuesday night. The meetings are presided over by Potenzo except when Giancana is present to take command.  $\cup$ Hodl has agreed to cooperate further with Agents in furnishing information on Giancana and will attempt to regain employ ment with Potenzo if possible in order to be in a position to gain additional inside information.
