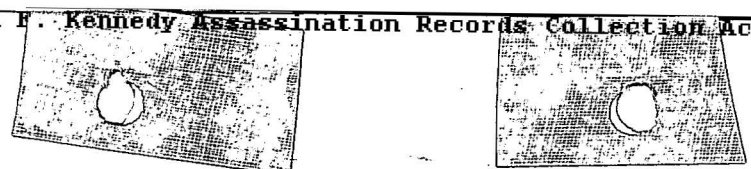

TECT IDENTITY ENPAREN RECONTACTED RE KNOWLEDGE OF GIANCANA-S ACTIVI-
TIES NORTHWEST SUBURBS OF CHICAGO. HODL ADVISED HE WAS POKER AND DICE
DEALER AND HANDLED BOOKMAKING OPERATIONS FOR APPROX. TEN YEARS
AT THE ~~WAGON WHEEL~~, CHICAGO, AND AT THE ~~RIVIERA~~, NILES, ILL. STATED
LEFT EMPLOYMENT IN AUG. LAST. SAID THAT CIRCUMSTANCES SURROUNDING HIS
LEAVING EMPLOYMENT WERE THAT LATE LAST SUMMER HE REQUESTED PERMISSION

GIANCANA INSTRUCTED STEVENS TO QUOTE TREAT HODL RIGHT UNQUOTE. HODL SAID THAT HE HAD NO TROUBLE WITH STEVENS AND WAS NOT CONTACTED BY HIM TO CLOSE DOWN BOOKMAKING OPERATIONS. NOTED THAT STEVENS INTERVIEWED BY BUREAU AGENTS RECENTLY AND SAID THAT HE INSTRUCTED HODL TO CLOSE DOWN BOOKMAKING OPERATIONS WHEN HE BECAME AWARE OF THEM. HODL ADVISED HE IS MAKING ATTEMPTS AT THIS TIME TO REGAIN HIS FORMER EMPLOYMENT WITH ROCCO POTENZO AT THE RIVIERA LOUNGE.
