On 10/18/65, DL 275-C-TE (DL 137-1733) advised that during the previous week, he had observed CHARLES CIVELLO at the liquor store on a daily basis. He advised that he also believes that he observed ROSS MUSSO at the store on almost a daily basis during the previous week. Informant stated that he observed JOSEPH CIVELLO at the liquor store on 10/13 and 15/65 during the morning hours.

On 10/13 and 15/65, CIVELLO's automobile was observed parked in the garage at his residence, located at 4908 Gulfstream.

On 10/18/65, DL 275-C-TE (DL 137-1733) advised that WESTBROOK, owner of the Olive Manor Motel, Burbank, California, had arrived in Dallas, Texas, on the night of 10/17/65 at Love Field Airport. He stated that WESTBROOK arrived late in the evening and remained at the Roadway Inn. On 10/18/65, WESTBROOK was introduced to Bureau Agents at which time he stated that he was in Dallas, Texas to visit with some friends and take a short vacation from his business in Burbank, California. WESTBROOK indicated that he would rather live in Dallas, Texas, than the California area; however, with his present business setup at the motel, it is impossible for him to leave the West Coast. WESTBROOK also discussed some of his background activities while he was in the St. Louis, Missouri area during the 1930's and 40's.

Informant stated that he had originally bought out ADAMS' sport service, but ADAMS has again entered the business and the informant is using ADAMS' services.

On 10/12/65, DL 208-C (DL 137-1530) advised that he has received information from associates that DAVIS is presently backing a bookmaking operation in Dallas, Texas, using money furnished him by a Mr. SMITH REYNOLDS, a wealthy businessman from Tyler, Texas. Informant stated that REYNOLDS is a former business partner of DAVIS, when they were in the oil lease business. Informant stated that DAVIS is still in business at Richardson, Texas, making electric dryers for poodles and believes that DAVIS is using GARLAND EUGENE POLLARD (DL 165-150) and possibly BOBBY JOE CHAPMAN (DL 165-151) to actually handle the bookmaking operation.
