PCI [redacted] advised on 11/30/66, that Dr. ZACHARIA and his wife, brother-in-law and sister of JOSEPH CIVELLO, from Rockford, Illinois, visited CIVELLO over the Thanksgiving holiday and then CIVELLO and his wife accompanied the ZACHARIAS to Baton Rouge, Louisiana, to visit relatives, the SAM CANGELOSIs. Prior to going to Baton Rouge, CIVELLO gave a private party at his residence for Dr. ZACHARIA and his wife and attending this party were CHARLES CIVELLO, ROSS MUSSO, PETER INTERRANTE, LUKE A. CORTEMEGLIA, CARLO LA BARBA, and JOHN ROSS PATRONO. PCI stated the builder who built JOSEPH CIVELLO's home was also present. PCI advised that MUSSO had been sickly lately, suffering from an ulcer.
