During past week, activities of subject have been followed on almost daily basis through investigation and assistance of DL 279-C. Informant reported subject planned to fly to Hot Springs, Arkansas, in private plane with E. PAUL WAGGONER, wealthy rancher from Vernon, Texas, and to be accompanied by one CHARLIE BROWN, reportedly wealthy rancher from Midland or Odessa, Texas. All three were to attend horse races, however, from what informant was able to learn, subject planned to take BROWN in crooked dice game while there. Subject was to have left Dallas on 2/22/67, but spent the evening of 2/21/67 and early morning of 2/22/67, drinking with other Dallas associates and missed 10 AM contact with WAGGONER and BROWN on 2/22/67. Subject, according to informant, made number of calls to Hot Springs, in effort to reach BROWN and WAGGONER at Hot Springs but was not successful. Subject has now apparently given up going to Hot Springs. Dallas had contemplated setting up surveillance of subject's departure and request Little Rock to establish surveillance while at Hot Springs. Subject is well-known Dallas gambler and dice hustler.
