Subject and wife returned to Dallas at 6:30 PM, 3/28/67, and were met at the airport, Love Field, by JOSEPH FRANCIS CIVELLO, brother-in-law of subject. CIVELLO is alleged boss of LCN, Dallas. Los Angeles Office had covered MUSSO's departure from Los Angeles.

DL 279-C advised on 3/27/67, of trip to Hot Springs, Arkansas, where CI saw number of Dallas gamblers and spent some time there with GREEN. CI stated GREEN had gone to Hot Springs after call received from GLENN EARNEST BURNETT, Dallas gambler, who was already in Hot Springs, asking GREEN to come. CI stated Dallas gamblers mostly played at the racetracks and frequented the night spots and GREEN apparently had no other purpose in going to Hot Springs other than to attend the races and be with BURNETT and others.

*ARKANSAS*

CI furnished some information to Senior Resident Agent at Hot Springs as to where several gamblers were staying
