Spot checks during the past week failed to disclose any unusual activity or contacts on part of subjects. Both continued to work part-time at the Airway Liquor Store, owned by CHARLES EDWARD CIVELLO, brother of JOSEPH. MUSSO has been seen working regularly at the liquor store.

DL 286-C has advised that BRUNO BRUCE has become active again as a bookmaker at Ft. Worth. BRUCE had been associated with FRED MYRICK. MYRICK sold the liquor store on 6/1/67, bought the Exchange Club at 108 East Exchange Street, Ft. Worth, and is now operating this club as a pool hall and tavern. Informant advised MYRICK had in the past backed BRUCE financially. Gambling cases have been reopened on BRUCE and MYRICK.

Spot checks of subject's residence and place of part time employment during past week indicated subject not following usual pattern of spending some time usually in the morning hours at brother's liquor store. As Bureau is aware, subject has been in contact with LA informant and one A. S. MARSHAL, longtime CIVELLO contact concerning arranging for loan from the Teamsters to purchase the Riviera Hotel in Las Vegas. In these contacts and conferences which have been held between above in Dallas, Kansas City and New York, LA informant was introduced to "Little Joe", friend of CIVELLO in Dallas. "Little Joe" is JOE IANNI, subject of Dallas AR file 92-192, and suspected member of the LCN.

MARSHAL was in Dallas on 8/25,26/67, staying at the Hilton Inn and the Sales Manager at the Hilton Inn, who had occasion to be in personal contact with MARSHAL, has positively identified a photograph of AARON MOSHIEK, FBI #479888, aka A. S. Marshal, as being identical with the A. S. Marshal, subject of new AR case opened by Los Angeles.

Dallas has located hotel records for MARSHAL on his recent visits to Dallas and has also obtained long distance calls made by him while staying at these hotels.

This airtel was delayed due to the fact the Agent was tied up on Grand Jury presentation of major case in Tyler, Texas.
